

Bibliographical Note

As of 2027, all references to Hume's works in *Hume Studies* are by the following abbreviations, in most cases followed by numbers designating major textual divisions and their paragraphs. (Thus T 1.2.3.4 designates Book 1, Part 2, Section 3, paragraph 4 of Hume's *Treatise*.) Abbreviations follow those employed in *Hume Texts Online* (<https://davidhume.org/notes/abbreviations>). Paragraph numbers correspond to those found in the Oxford Clarendon editions, where they exist, and in *Hume Texts Online*. Exceptions to these policies are mentioned along with the works that employ them.
